The Molecular Genetics Laboratory provides gene testing in constitutional and acquired diseases using a full range of classical and advanced genetic technologies including real time PCR, microarray and next generation sequencing. The Medical Laboratory Technologist will perform molecular genetic procedures in accordance with written Laboratory protocols and Provincial Licensing Regulations under the general supervision of the Section Head.
